Join us Sunday, March 21st in New York City to hear the voices of service members and veterans wrestling with profound questions about the morality of the wars they are called upon to fight. The Truth Commission on Conscience in War will bring people together to hear from recent veterans, military chaplains, religious leaders, and legal experts about the issues of moral and religious conscience facing our nation's service members.

The Commission will:

- (1) Honor and protect freedom of conscience for service members,
- (2) Bring together Just War, Just Peace, and pacifist traditions in conversation, and
- (3) Address the moral and spiritual injuries of war.

Over 70 Commissioners from pacifist, Just War, Just Peace, and other traditions will attend the Public Hearing to receive personal testimony from veterans and expert witnesses about:

- (1) Moral and religious questions facing soldiers both before and during combat,
- (2) Moral and religious criteria of just war,
- (3) International agreements governing the justification and conduct of war, and
- (4) Limits of current military regulations on Conscientious Objection.

Commissioners and testifiers will meet in Private Session on Monday, March 22, to discuss the Public Hearing testimony and identify strategies for pursuing the goals of the Commission.

On behalf of the Commission's nearly 50 organizational sponsors and co-sponsors, we hope you will join us for the March 21 Public Hearing at The Riverside Church. Together we will launch a major nationwide conversation about just war, international law, and freedom of conscience for members of our nation's armed forces. We owe this to our service members and their families, to our faith communities, and to our nation.
